



## Rules of the Verbier Sports Centre

### I. TERMS AND CONDITIONS

#### Opening

##### Art.1

1. The Sports Centre is open all the year around, according to the schedule defined week by week. The schedule may be subject to change.
2. Sectors can be closed as required.
3. The entry fee entitles the holder to use the relevant facilities within the Centre Sportif de Verbier **on the day the ticket is issued.**  
**All exits are final!**
4. Anyone using facilities that do not correspond to their entry fee will be required to pay for the activity in question.
5. Only associations or individuals who have received written authorization are allowed to give paid lessons.
6. The user gives the Verbier Sports Centre permission to publish, exhibit or broadcast the photograph or videos taken in the Verbier Sports Centre. This authorization is valid for any use (publications, website, social networks, etc...).

#### Security

##### Art. 2

The users adopt in all circumstances a reasonable behavior, prudent and respectful of his own safety and that of the other users.

#### Children

##### Art. 3

Minor children, even if unaccompanied, remain under responsibility of their legal representatives.

#### Area of the center and surroundings/hygiene and cleanliness

##### Art. 4

1. Users agree to respect the premises and keep them clean.
2. Everyone is responsible for their own waste. These must be thrown in the bins provided for this, including chewing gums
3. The keys must be handed over to the staff of the center as soon as the premises have been used.

#### Infrastructures

##### Art. 5

##### Climbing

1. There is no admission charge for accompanying persons or persons providing insurance only.
2. The Centre Sportif de Verbier reserves the right to limit the number of participants.
3. Certain areas may not be accessible to the public.
4. Children under the age of 14 must be accompanied by an adult. From the age of 14, parents may sign a disclaimer authorizing their child(ren) to climb unsupervised.

## Subscription

1. Subscriptions are personal and non-transferable.
2. In the event of misuse of a subscription, the persons concerned may have the subscription withdrawn.
3. Annual and 10-ticket season tickets are valid for one year from the date of purchase. If a season ticket is not used, no refund can be requested.
4. In the event of incapacity of at least 30 days (accident, illness or pregnancy), the season ticket may be extended following the incapacity only on presentation of a medical certificate stating the start and end dates of the incapacity.

5. In the event of prolonged closure (more than 7 days) due to absolute necessity, the subscription may be extended for the corresponding period, on simple request.

6. For a particular event, the Centre Sportif de Verbier or part of it may be inaccessible. No refund can be requested.

## **Equipment rental**

### **Art. 6**

The hirer :

- is responsible for the rented equipment and takes care of it until it is returned
- notifies the person responsible of any damage to the equipment

In the event of misuse, the hirer will be responsible for restoring the rented equipment.

## **Rules of conduct**

### **Art. 7**

Users of the Sports Centre:

- a. respect the surroundings and the neighborhood by avoiding noise and depredations
- b. behave courteously towards each other and the staff
- c. use with care space and equipment provided.
- d. do not engage in any shirtless activities.

## **Responsibility**

### **Art. 8**

The Commune of Val de Bagnes accepts no responsibility for users, accidents, theft, etc...  
All users must have their own accident, health and third-party insurance.

## **Online sale**

### **Art. 9**

1. Reservations are required for use of the tennis courts, squash courts and any activity on the OM pitch.
2. Reservations (except for the OM pitch) can be made via the online reservation platform.
3. Upon presentation of proof of identity or your season ticket at the Sports Centre reception desk, and after payment, you will be given access to the reserved pitch. If you are not there within 15 minutes of the start of your reservation, it will be given over to other customers on standby.
4. The Centre Sportif de Verbier may cancel any reservation. In this case, no compensation will be paid and the reservation may be refunded or moved.

5. All bookings may be cancelled free of charge up to 24 hours in advance. For any cancellation within 24 hours of the reservation, the customer must pay 100% of the amount due.

## **II. PENAL CONDITIONS**

### **Principle**

#### **Art.10**

Any person who doesn't observe the present regulations or doesn't follow up on the observations of the Sports Centre's staff will be subject to sanctions, without prejudice to more severe penalties that the offender may incur under the federal and cantonal legislation.

### **Bans**

#### **Art. 11**

It is strictly forbidden to :

1. wear shoes with black or distinctive soles on the grounds of the OM hall;
2. bring in animals
3. staying unnecessarily in the changing rooms and shower rooms;
4. to throw paper or rubbish of any kind anywhere other than in the bins reserved for this purpose;
5. bring bicycles, scooters, skis or snowboards into the Sports Centre;
6. take photographs or film.

### **Decision authority**

#### **Art.12**

All the staff of the sports center is able to take immediate action against those who violate this regulation.

### **Warning**

#### **Art.13**

Faults of little seriousness will be sanctioned by an oral warning.

### **Expulsion**

#### **Art. 14**

1. In serious cases, the Sports Centre's staff will expel the offender.
- 2.The sports centre's subscription may be withdrawn and will not be refunded

### **Other measures**

#### **Art. 15**

Following expulsion, the Commune of Val de Bagnes will decide whether to impose a ban on use for a specified period and if necessary, it may also decide to return the season ticket immediately.

### **Entrance fees**

#### **Art. 16**

Anyone failing to pay the admission fee may be reported to the Public Prosecutor's Office. He/she will be liable to a fine

### **Public force**

#### **Art.17**

If an offender proves to be recalcitrant, the police may be called.

### **Right of appeal**

#### **Art.18**

Any penalty imposed by the Commune of Val de Bagnes may be appealed in writing to the Administration Communale within 30 days.

### **III. FINAL CONDITION**

#### **Coming into force**

##### **Art. 19**

These regulations come into force immediately.
